<ul> <li>2.1 Joint working committee session planned for Friday 19 Oct in Chicago A preparation call with all working committee co-chairs took place on 17 Sep. After the call, Amir Khwaja, CEO from ClarusFT informed MZ, that he will attend the FIA Expo as a speaker and could also come to the CCP12 meetings. <b>2.2 Updates from OWC</b> KM attended a roundtable meeting organized by CPMI-IOSCO on cyber risk in Paris on 14 September A debrief will be given at the SGM.	
<b>2.3 Updates on PQDWG</b> The release of the first bulletin was executed on 28 Aug (CCP12 internal) and 30 Aug (public). The work on the long version is ongoing. The WC call had to be rescheduled from 20 Sep to 27 Sep due to a conflict with the call by Nasdaq on the clearing member default.	
2.4 Updates from PWC Incentives for Central Clearing (Consultation by the FSB/BSBC DAT due 7 Sep) Response was submitted on 07 Sep to FSB and BCBS.	
Meeting with FSB on 14 Sep (Attendees CCP12: Teo Floor (ECAG), Emily Hendrix (CME), Nicholas Lincoln (LCH Ltd), Zhu Jia (SHCH), Jia Fan (SHCH), Xu Zhen (SHCH), Marcus Zickwolff (CCP12))	
MZ reported, that the importance of central clearing is understood and there is an awareness on the concerns in regards to the Leverage Ratio. There is an intention to influence the regulation, however a timeline was not given.	
On Resolution a consultation will be send out at the end of 2018 for comments by Jan/Feb 2019. An industry roundtable meeting by CPMI-IOSCO is scheduled for 29 January 2019 in Madrid.

In regards to the FSB study on interconnectedness, MZ reported, that FSB confirmed in the new study not many changes/new information in comparison to the former one could be presented. Another follow-up study can be expected for 2020, but this is not decided yet.

The FSB informed that for 2019 stress testing will be added to the work plan. An update of the work plan will be provided at year end.

RI reported on an ISDA lobby effort on the SLR, to which CCP12 may contribute or prepare a support letter.

## 2.5 Updates from RWC

DMP Auctions with BIS on 13 Sep (Attendees CCP: Dale Michaels (OCC), Kevin McClear (ICE), Nicholas Lincoln (LSEG), Sergey Arefiev (CME), Jia Zhu (SHCH), Marcus Zickwolff (CCP12))

DM reported from the meeting at which 5 Clearing Members, 5 CCPs and approximately 20 regulators were present. The buy-side was not invited. The CMs and CCPs were in most points aligned, in only a few the views varied e.g. on minimum bids. Especially on the best practices and the porting of customers, additional guidance was sought by the regulators.

TF reported on a bilateral conversation with Daniela Russo and the unlikeliness of a regulation on this topic. Industry set standards is likely to be more promoted.

# Consideration of response on FED PRC / JPM IM paper

The recently published paper of the FED PRC was discussed as well as the paper by JPM on Initial Margin. As there are some inaccuracies in the paper, DM, LB and TF considered to draft a response.

#### Proposal for a CCP12 fire drill workshop in Singapore on 30 Nov

The outline was exchanged with and approved by the RWC Co-Chairs. 16 places are available (1-2 participants per member) and it can be repeated also in other time zones. MZ mentioned this also in the DMP Auctions meeting and the regulators were very interested in this workshop. Therefore it can also be offered to regulatory authorities in the future, however firstly the members shall be invited.

#### 3.2 Conferences

#### **3.2.1** 18 Oct SGM

The room at the Hilton Chicago is booked and the meeting materials are in preparation. The draft agenda with the above mentioned change on the introduction of ClarusFT was approved by the ExCo and will be circulated to the membership. In accordance with TC, GARP will be included in one of the next AGMs.

In regards to the budget for 2019 a budget proposal was circulated to the ExCo at which is proposed to proceed with the current budget and membership fee set up. Further comments can also be provided to MZ bilaterally by 25 Sep. It will then be circulated to the membership.

For 2020 the membership fee model has to be revised. MZ will provide a proposal for discussion with ExCo in Q2/2019.

**3.2.3** 05 Nov (planned) Release of the PQD bulletin long version, Shanghai **3.2.4** 2019 AGM

It is proposed to have the AGM in 2019 in London in June in conjunction with IDX. However as the timing might be too late, it was also proposed to combine it with the CPMI-IOSCO Session on Resolution in Madrid. Furthermore it was advised to organize a panel and invite regulators for a discussion in conjunction with the AGM.

The 2019 Symposium on OTC Derivatives will take place again in Shanghai end of June.

The preparations for the 2019 SGM in autumn has not yet started.

#### 3.3 Association management support/consultancy

**3.3.1** Position paper on Incentives for central clearing and non-clearing The RfP resulted in decision to go forward with ClarusFT and the budget request for the white paper is 92k \$ (plus tax and expenses). As currently the remaining budget on consultancy for 2018 is 76k \$, it is proposed to shift not needed budget from training (40k \$), conferences (30k \$) and secondment program (34k \$) to consultancy.

The contract with ClarusFT is currently prepared.
